1	8-18-1970	An ordinance granting to California-Pacific Utilities Company an electric light, heat and power franchise.
7	9-10-1970	An ordinance granting a franchise to the United Telephone Company of the Northwest, its successors and assigns, to construct, maintain and operate in and upon the streets, highways, bridges, and other public places within the corporate limits of the city of Seneca, Oregon, a general telephone business for a term of twenty years, subjecting such telephone service at all times to regulation by public authority, providing for payment to the city of Seneca, compensation for the exercise of said franchise and specifying other limitations, terms and conditions governing the exercise of said franchise.
14	4-22-1972	An ordinance providing for the calling of a city tax base election in the city of Seneca, Oregon, on May 23, 1972, for the purpose of submitting to the legal voters of the city of Seneca, Oregon, the question of establishing a tax base for the purpose of applying the limitation of taxation set forth in section 11, article XI, Oregon constitution.
16	6-20-1972	An ordinance calling for a special election for the purpose of submitting to the voters of the city of Seneca, Oregon, for their approval or rejection an amendment to the charter of said city, authorizing the improvement of and increasing the capacity of the water system of the city, and directing, authorizing and empowering the council to issue and sell general obligation water bonds of said city in an amount not to exceed \$165,000.00 to pay for the same; and declaring an emergency.
17	6-20-1972	An ordinance calling for a special election for the purpose of submitting to the voters of the city of Seneca, Oregon, for their approval or rejection a measure authorizing the construction of a sewer system and directing, authorizing and empowering the

		common council to issue and sell general obligation sewer bonds of said city in an amount not to exceed \$160,000.00 to pay for the same and to declare an emergency.
18	2-26-1973	An ordinance accepting the offer by the county court of Grant County, Oregon, to surrender jurisdiction over all county roads lying within the corporate limits of the city of Seneca, Grant County, Oregon, and declaring an emergency.
20	5-15-1973	An ordinance providing for the issuance of negotiable general obligation bonds of the city of Seneca, Oregon, in the principal sum of \$160,000.00 at an interest rate of not more than five percent, for the purpose of providing a portion of the costs of acquiring, constructing, reconstructing, repairing, extending and improving the sewer system for the city of Seneca and providing for the collection, handling and disposition of revenues, and authorizing and directing the city recorder to advertise for written bids on said bonds and declaring an emergency.
21	6-19-1973	An ordinance authorizing and providing for the issuance of general obligation bonds in the principal amount of \$160,000.00 at an interest rate of five percent to Farmers Home Administration for the purpose of providing a portion of the costs of acquiring, constructing, reconstructing, repairing, extending and improving the sewer system for the city of Seneca and providing for the collection, handling and disposition of revenues, and declaring an emergency.
23	4-2-1974	An ordinance providing for the issuance of negotiable limited general obligation promissory notes of the city of Seneca, Oregon, in the aggregate principal sum of \$160,000.00 for the purpose of providing interim financing for a portion of the costs of acquiring, constructing, reconstructing, repairing, extending and improving the sewer system for the city of Seneca and authorizing and directing the city recorder to advertise for written bids on the said notes and declaring an emergency.
