1. Call to Order

Mayor Officer called the meeting to order at 6:00 PM and confirmed quorum.

2. Old Business

a. Iron Triangle Water Access and Use Agreement

Council discussed the finalized agreement with Iron Triangle, including cost sharing and maintenance responsibilities.

- Motion made by Councilor Northington to approve the agreement as written.
- Seconded by Councilor Herburger.
- Motion passed unanimously.

3. New Business

Minutes from the June 10, 2025 Regular Meeting and June 26, 2025 Special Meeting were reviewed.

b. Open Floor Discussion

- A resident requested exemption from dump fees due to use of a private dump site; council reminded all that exemption requests must follow the existing resolution and be submitted in writing for documentation.
- Resident requested water reading dates on utility billing.
- Sewer availability billing was discussed. Resident pointed out that the rate went up by 50% in comparative to the regular utility rates.

c. Verizon Underground Line Route

Council reviewed and approved by consensus Verizon's updated underground path near the shooting range.

d. Seneca Paving Project Update

- Council was briefed on a scope adjustment to the Shirttail Creek Road paving project to remain within budget.
- Concerns were raised regarding access through a property owned by Connie Brown; Grant County is being consulted for easement clarification.
- Heckman Construction remains the approved contractor for the project as previously voted.

e. Broadband Network IGA Termination

- Council reviewed and approved the termination of the intergovernmental broadband management agreement and repealed Ordinance Nos. 94 and 95.
- Motion made by Councilor Northington, seconded by Councilor Wenick.
- Motion passed unanimously.

f. Lease Agreement Review

- Council reviewed all active grazing and business lease agreements.
- Topics discussed included lease compliance, fencing maintenance, potential lagoon use for grazing, fair lease access for other residents, and reminder communications to lessees.
- Motion made by Councilor Herburger to approve all lease agreements as presented. Seconded by Councilor Herburger.
- Seconded by Councilor Wenick.
- Motion passed unanimously.
